

REQUIRED DOCUMENTS

Students will need to present the following documents at their local Texas Department of Public Safety Driver License Office when applying for a Texas Instruction Permit or Driver License:

- (1) a completed Texas Driver License Application (form DL-14A supplied by school). The application must be signed in front of a driver license official.);
- (2) an application fee of \$6.00 for an Instruction Permit or \$24 for an unrestricted Driver License (cash, check or money order);
- (3) if previously licensed (including an instruction permit) in another state, the out of state license must be surrendered or a Department affidavit must be executed which indicates the out of state license was been lost, stolen or expired;
- (4) if the student owns a vehicle for which proof of financial responsibility is required, then evidence of liability insurance must be presented;
- (5) an original Social Security Card or other acceptable proof of social security number;
- (6) an original birth certificate or other acceptable proof of name, date of birth, and place of birth (refer to link below); and
- (7) documents to prove lawful status for those students who were born outside of the United States of America.

Important: All documents must be originals. All state-required driver license forms must be completed in BLACK INK ONLY.

(SPANISH IDENTIFICATION DOCUMENTS)

Documentos Aceptados Para Identificación

Primario (Se acepta sin ningún otro documento)

- Tarjeta de Indentificación del Estado de Texas (Que no esté vencida por más

de dos años)

- Pasaporte de los E.U. vigente
- Documentos de Inmigración Vigentes:
 - Tarjeta de Residencia (I-551)
 - Tarjeta de Autorización de Trabajo (1688A)
 - Pasaporte extranjero con visa vigente por el Departamento de Estado de E.U.
 - Pasaporte extranjero con tarjeta I-94 vigente
 - Tarjeta fronteriza (USA B1/B2, VISA/BBC)

Secundario

- Licencia de manejar de otro estado o tarjeta de identificación vigente y con foto de los E.U.
- Original o copia certificada de una orden de la corte con nombre y fecha de nacimiento
- Aplicantes nacidos antes de 1961, aceptamos:
 - Original o copia certificada de forma DD-214
 - Original o copia certificada de otros datos del gobierno. (Como datos de los censos o del seguro social.)

Soporte

- Datos escolares
- Título de auto
- Original o copia certificada del certificado de matrimonio o divorcio
- Documento consular dado por un estado o gobierno nacional (tarjeta actual)
- Pasaporte extranjero sin visa de los E.U.
- Tarjeta de registro para voltar (tarjeta actual)

Es necesario presentar una forma de identificación secundaria con dos (2) formas de documentación. O bien, dos formas de documentación secundaria para identificarse.
